The information we collect

We are committed to protecting your privacy.

We do not collect personally identifiable information about you when you visit this website, unless you choose to give it to us by completing an online form on this website or by registering for our newsletter.

If you do choose to give us your personal details (such as your name, email address, telephone number etc) our staff may access this information to better understand your interests in our services. Your personal data will only be used for the purposes you provided it for.

While we do not collect personally identifiable information about you if you visit our website, we do analyse non-identifiable web traffic data in order to help improve our website. This information does not identify you personally and is not linked to any personally identifiable information that you may have provided. Who we share this information with

Google Analytics

We use Google Analytics software to help measure traffic patterns to, from, and within our website. This service is used to anonymously aggregate website statistics such as number of page views, the number of visitors, time spent on our website, browser types, and common entry and exit points into and from the website.

All information is aggregated by Google Analytics and provided to us to help us better understand usage of our website – no individual visitors are identified. Google Analytics is a leader in the Internet industry and their systems have been adopted as an accepted website traffic measurement standard amongst major Internet sites.
